Your organization will receive a 3-year valid certificate requiring surveillance of your organization.

Third-party HACCP certification offers that a team of competent and impartial professionals verify

that your organization has an effective safe food system. Successful implementation of BRS HACCP MS will help organizations discover and avert potential hazards tainting food and drink and propitiates validation of the HACCP while adhering to legal and regulatory requirements.

#### Why Certification—Validation?

Upon successful assessment, this will demonstrate to others that your organization abides by the principles and requirements of HACCP as determined by law. Equally it will help in managing fulfillment in accordance with

better practices as these relate to food safety. We provide a guidance document HACCP MS as well verification checklist to client organizations.

Certification will improve overall food safety performance, remove uncertainty and entice market opportunities and growth.

BRS is third-party HACCP certification body providing FSMS (Food Safety Management System) HACCP MS and ISO 22000 certification.

### THE ROUTE TO CERTIFICATION

**Application:** Contact BRS and request application form (questionnaire).

**Application Process:** BRS from the Rim of the World Office reviews the questionnaire, study your needs and present you with a quote to meet your organization's specific needs for the purpose to protect consumers.

**Selection of BRS:** Once your organization selects BRS for HACCP certification the organization agrees to Term of Business Agreement (TBA).

**HACCP Team Appointment:** BRS selects and present to the organization for the organization to accept, the team could comprise of local and/or global members.

**Phase I:** This is the initial stage of assessment with the objective gather information on your organization and to discuss the level of readiness to continue to Phase II HACCP toward certification. This will help to achieve certification during Phase II.

Note: We may combine the Phase I and Phase II visit for small organizations.

The time allowed between Phase I and Phase II is not to exceed 90 days.

**Phase II:** Is with the objective to recommend your organization to issue a HACCP "Certificate of Registration", after the organization is assessed against HACCP MS. Upon successful completion of the assessment protocol the certificate is issued.
